Corrigendum Notice

The Bidding Document and the corresponding Invitation for Bids (IFB) for the: -

Construction of DTWs (Remaining DTWs of ICB-02.11) under DWSNIP, DWASA. (Package No. NCB-02.6)

Issue dated on 13 February 2022 (Ref.: Memo No.: 46.113.624.00.00.908.2021.353, dated: 13.02.2022); has the following amendment:

Section-3 Evaluation and Qualification Criteria (EQC) Clause 2.3.2

The text shall be changed as follows:

Minimum average annual Construction turnover of **BDT 140,000,000.00** calculated as total certified payments received for contracts in progress or completed, within the last 3 years.

Section-3 Evaluation and Qualification Criteria (EQC) Clause 2.3.3

The text shall be changed as follows:

For Single Entities:

The Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of **BDT 22,000,000.00**

For joint venture point 3:

The joint venture must demonstrate that the combined financial resources of all partners defined in FIN - 3, less all the partners' total financial obligations for the current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of **BDT 22,000,000.00**

Section-3 Evaluation and Qualification Criteria (EQC) Clause 2.4.1

The text shall be changed as follows:

Participation in at least 2 (two) contracts that have been successfully or substantially completed within the last 5 years and that is similar to the proposed contract, where the value of the Bidder's participation in each contract exceeds **BDT 72,200,000.00** The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements).

Section-4 Bidding Forms Clause Bill of Quantities

In bill of Quantities, part C: bill of quantities shall be changed instead of Lump sum unit for the construction of Pump House, Delivery line, Wash out line, R.S Joist and Boundary Wall for 9 nos. DTWs.

All other information of the Bid Data Sheet (BDS) and the Invitation for Bids (IFB) shall remain unchanged.
